Interim report by Mag. Dr. Wolfgang Meixner on the curriculum vitae of Dr. Hans Klocker, his wife Emma, his son Wolfgang, as well as on important persons both in his private and his professional life (as of November 10, 2022)

So far, in the process of establishing the facts about Dr. Hans Klocker's life, his biographical estate at the Klocker Foundation has been cursorily examined. It consists of letters and postcards to his (later) wife as well as to relatives, friends, flying comrades, and work colleagues. Moreover, various certificates and documents have come down to us (especially from the National-Socialist era and his time in the German Wehrmacht).
